



## **International dance festival-competition „SUMMER VIBES 2026”**

**Date of the event: MAY 17, 2026**

**Location: VEF Culture Palace (Ropažu Street 2, Riga)**

### **The aim and tasks of the festival-competition:**

- To create the festival-competition that takes place every year for experience exchange promotion among the different types and genre dance collectives and solo dancers.
- To find and support new dancers, solo dancers and dance collectives.
- Exchange of experience and skills among the dance leaders.
- Opportunity to show the dancing skills for every child.
- To strengthen mutual understanding and friendship among children and youngsters from different countries.
- To improve the artistic mastery.

## **Conditions of the festival-competition:**

### **Forms:**

- solo
- duet
- trio
- groups (from 4 people)

### **Groups of age:**

- Participants have to belong to one age group, no more than 10% of the whole group can be of the different age. Organizers can also check documents if they are in doubt about the age of the dancer.
- \*The age group of groups and Mix is determined by the average age of the participants.

**Attention! If there is insufficient number of participants in the group or nomination, the organizers are eligible to unite them to the next standing group without a warning.**

## **Nominations:**

### **I. CHOREOGRAPHY**

1. **Kids dance** (from 3 years old to 9 years old)
2. **Stage dance** (show dance, modern dance, contemporary, jazz dance, oriental etc...)
3. **Folk dance&Scenic folk dance**
4. **Urban** (street dance, hip-hop, house, cheerleading and other modern dance styles)
5. **Classical dance&Neoclasical dance**
6. **High Heels** (blends multiple styles and is characterized by the use of high heels)

## II. CIRCUS ART / ORIGINAL GENRE

2. clowning
3. gymnastics (sports number)

### Financial requirement:

### Technical options:

- **Dancing and performances are required to be a maximum of 4:00 min long.**
- **The music/foto/video should be sent to the given e-mail by 27.04.2026**  
The file should be in **MP3 format**, the title should consist of the collective's name and the title of the dance (For example, **perlite\_flowerdance.mp3**)
- Each participant can use the own video or picture on led-screen as a background and additional visualization during the dancing performance. The title should consist of the collective's name and the title of the dance.

**Video Format: MP4 h264, Prores 422, DXV3**

**Picture: .jpg .png. Size of the picture: Min 1920x1080, Max 3840x2160**

## **Process of the festival-competition and evaluation of the performance:**

### **Criteria of evaluation:**

**All participants are evaluated by for positions:**

- Choreography (idea, originality)- **from 0 to 10 points;**
- Technical performance of the dance (accuracy, synchronicity, complexity)- **from 0 to 10 points;**
- Musicality of the performance- **from 0 to 10 points;**
- Visual appearance /scenic (costume, performance culture, age appropriateness) - **from 0 to 10 points;**

**After which the points are summed up to get the average.**

### **Prize fund and awarding:**

**SPECIAL PRIZE- 200 EUR from FESTIVAL ORG and gifts from partners**

**29-40 points – 1 place**

**22-28,99 points – 2 place**

**14-21,99 points – 3 place**

**8-13,99 points – 4 place**

**0-7,99 points – 5 place**

**Attention! During the awards ceremony only the leaders and teachers of the collective with 2 dancers, solo, duet and trio dancers can come up the stage.**

**All participants will get awarded with places for each performance according to the points obtained. It's acceptable for duplicated places (two of first place, two of second place, etc.), ACCORDING TO THE POINTS OBTAINED. Participants will be awarded with OBTAINED PLACE diplomas, and medals. Letters of thanks to the leaders are awarded. Also, each collective receives ONE commemorative cup of the competition. The jury's decision is final and cannot be changed.**

### **Members of the jury:**

Jury consists of competent persons in their professions.

## **Photo and video:**

During the festival-competition there will be professional photographers. The photos will be displayed in the festival-competition website after the event.

The application for the festival-competition **is certification of your approval that photo and video materials, which are taken during the event, can be used in commercial purpose by the organizers.**
